### 1. Background

Financial Regulation (2022) 2.4 provides that "Unless otherwise decided by the Commission, for the budget category 'Scientific Support' unspent appropriations may accrue between financial years, up to a limit of \$50 000. Beyond this level such funds shall be treated as surplus and transferred to the accumulated surplus account."

A separate account was established in 2017 for the Scientific Support Fund. This Fund contains the accumulated unspent appropriations from previous Financial Years (beginning from Financial Year 2015-16).

### 2. FAC11 considerations:

The basis for the proposed Scientific Support Fund allocation for 2024-25 of **NZ\$186,000** is the SC11 Multi-Annual Workplan (<u>SC11-Report, Annex 5, Page66-73</u>), in which new funding requirements have been identified.

- **Recommend** that the Commission approve the proposed budget amount of NZ\$186,000 for Budget Category 9 Scientific Support for the Financial Year 2024-25 (FAC11-Doc07).

## 3. Status of Scientific Support Fund

### 3.1 The Year-to-Date Status of the Scientific Support Fund

Table 1 below shows the year-to-date status of the Scientific Support Fund up to 30 November 2023, which is in line with the expected expenses identified from the 2024 Scientific Committee Multi-Annual Workplan.

### *3.3 The Proposed Budget for the Scientific Support Fund in Financial Year 2024-25*

In the Draft Budget for Financial year 2024-25 (FAC11–Doc07), the proposed budget for Scientific Support is NZ\$186,000. This figure is sourced from the SC Multi Annual Workplan (SC11-Report Annex 5). This includes support for the JM assessment, ongoing Connectivity research and a 2024 squid workshop.

These new funds have been combined with the historic unused balance, a totalling NZ\$97,570 funds are currently available for collecting and analysing genetic samplings (Convention area and adjacent National Jurisdiction Areas).
